The Membership Code defines who has the right to be part of the Nation Micmac de Gespeg. Band membership is the right to be considered a member belonging to a Nation and to participate in the political life of that nation, that is:

- To take part in decisions at the general assembly.
- to vote;
- To stand as a candidate in elections, and
- To take advantage of certain other benefits such as resource sharing.

The Membership Code is a social project and all members of Gespeg are called to take part in it: We must not let others decide for us. All relevant documentation will be posted on the secure section of the Council's website, in the secure section, and will be sent by email to those who have provided us with their email address. Copies will also be available for viewing during the sessions for those who do not have internet access.
